



Neyland Drive Area Utility Upgrades



Project Information Sheet

Scope of Work

- KUB will have ongoing utility work along sections of Neyland Drive starting December 16, 2018, through December 2020
- Replacement of water main from December 16, 2018, through mid-January 2019
- Kuwahee Wastewater Treatment Plant Upgrades from January 2019 through December 2020

Project Overviews

- **Water:** 1,470 feet of 8-inch water main, 1 fire hydrant, 6 service lines
- **Plant upgrades:** construction of a Biologically Enhanced High Rate Clarification System (BEHRC) at existing site to provide full treatment capacity during peak wet-weather flows

Traffic Impacts

- **Water Main Construction**
(December 16, 2018 through mid-January 2019)
 - Neyland Drive: temporary lane shifts and single lane closures as needed for construction
- **Wastewater Plant Upgrades** (January 2019 through December 2020)
 - Neyland Drive: eastbound curbside lane closed and traffic flow shifted to center turn lane (see map on reverse)
- Entire project area will not be impacted at one time
- Electronic message boards and traffic channeling devices will be in place to assist with maintaining traffic flow

Greenway Impacts

- **Water Main Construction**
(December 16, 2018 through mid-January 2019)
 - Neyland Greenway closed between Lake Loudoun Boulevard and Third Creek
 - Detour through the University of Tennessee campus via Lake Loudoun Boulevard, Volunteer Boulevard, Andy Holt Avenue, Joe Johnson Drive, Solutions Way, and the Third Creek Greenway
 - Large site signs with a map showing the closed section of Neyland Greenway and detour will be posted at several locations along greenways and routes in the vicinity
- **Kuwahee Plant Upgrade Project**
 - Neyland Greenway closed intermittently between railroad bridge area and Joan Cronan Way
