To receive a rebate, this form must be completed in its entirety, and a copy of the sales receipt and installation invoice must be provided. Physical inspection for verification may be required. KUB reserves the right to verify sales receipts, model numbers and installation information. KUB also reserves the right to request additional documentation.
