UPDATE:

Sequoyah Square/Taliluna Avenue Natural Gas Main Replacement – KUB Underground Construction pipeline installation crews have completed installation of approximately 1,400 linear feet of new 2-inch plastic natural gas main in the north and south areas of the Sequoyah Square complex at 3636 Taliluna Avenue. Minimal work remains to tie-over service lines at existing meters and disconnect and condemn the old steel main. Remaining work will be performed as warmer weather returns this spring. Sequoyah Hills Phase 3 Wastewater Rehabilitation Status Update –

Traffic Impacts [March 1-5] – KUB contract crews will temporarily close the section of Cherokee Boulevard between Kingston Pike and Cheowa Circle from 7 a.m. – 6 p.m. daily, Monday, March 1 through Friday, March 5, as work is performed on wastewater collection system in the area. The turn lane of Kingston Pike to Cherokee Boulevard will also be closed during this time, and through traffic will be detoured to Scenic Drive. Local traffic access will be maintained, and flaggers will be on site to assist with traffic control. The roadway will reopen to normal traffic flow outside of work hours.

Additional Phase 3 area traffic impacts for week of March 1-5:

- Intermittent road closures
 - North and south intersections of Bluff Drive and Cherokee Boulevard
 - Kenilworth Drive between Scenic Drive and Oakhurst Drive
- Intermittent lane closures as needed during work hours:
 - Woodland Court (access for local residents will be maintained)
- Wastewater rehabilitation in off-road easements
 - Easement between Cheowa Circle and Cherokee Boulevard
 - Easement off of Glenfield Drive
