Re: Traffic Advisory – Lane/Road Closure Utility Work [All closures and work are weather permitting]

**(Downtown) E. Summit Hill Drive Lane Road Closure [October 13]** – KUB crews will close a short section of E. Summit Hill Drive to through traffic between Lula Powell Drive and S. Bell Street from 6 a.m. – 4 p.m., on Sunday, October 13, as work is performed on the water distribution system in the area. Alternate routes include Lula Powell Drive. Flaggers and signs will be on site to assist with traffic control, and follow-up advisories will be issued as necessary.

**(South Knoxville) Sevier Avenue Lane Closure [October 13]** – KUB crews will reduce a short section of Sevier Avenue to one alternating lane of traffic between Davenport Road and Jones Street from 6 a.m. – 3 p.m., on Sunday, October 13, as a fire hydrant is installed in the area. The westbound lane will be closed while the eastbound lane remains open to alternate traffic through the work zone. Flaggers and signs will be onsite to assist with traffic control.

**Sequoyah Hills Area Traffic Impacts (October 14–18)** – KUB contract crews will implement the below indicated traffic control measures during work hours, 7 a.m.- 5 p.m., Monday-Friday, October 14–18, as work continues on the wastewater collection system project in the area:

- Intermittent road closures as needed during work hours:
  - o Bluff View Road between Southgate Road and Holloway Drive
  - o Kenesaw Avenue between Cherokee Boulevard and Taliluna Avenue

**(East Knoxville) Road Closures [October 14-25]** – KUB contract crews will implement closures on the below roadways for ongoing wastewater collection system work in the area:

- Ivy Street between Ault Street and Jamey Street – October 14-18, 7 a.m. – 6:30 p.m.
- Holston Drive between Meadow View and Holston Court – October 16-25, 9 a.m. – 3 p.m.
- Michael Street between Norwalk Avenue and Holston Drive – October 16-25, 7:30 a.m. – 6:30 p.m.

No work will occur on weekends. Local traffic access will be maintained. Follow-up advisories will be issued as necessary.

Some listed closures may extend beyond the scheduled times depending on the conditions encountered during excavation and construction. Appropriate traffic control measures will be in place at each location to assist motorists traveling in these areas. Due to the ongoing presence of workers and equipment, motorists are advised to use caution and expect temporary delays in these areas. Tennessee's **Move Over Law** requires motorists approaching a utility vehicle with flashing lights to move over if safe to do so, creating an empty lane buffer. When changing lanes is not possible, motorists must reduce speed.
