Re: Traffic Advisory – Lane/Road Closure Utility Work [All closures and work are weather permitting]

(Old City Area) E. Depot Avenue Road Closure [November 30 – December 7] – KUB crews will close a short section of E. Depot Avenue between Morgan Street and N. Central Street continuously from 3 p.m., Friday, November 30, through 3 p.m., Friday, December 7, as work is performed on the water distribution system in the area. Alternate routes include E. Magnolia Avenue, E. Jackson Avenue, and Willow Avenue. Signs will be on site to assist with traffic control. Follow-up advisories will be issued as necessary.

(South Knoxville) Chapman Highway and W. Hendron Chapel Road Lane and Road Closures [December 3 & 10] – KUB contract crews will implement the below traffic control measures on Chapman Highway and W. Hendron Chapel Road from 7 a.m. – 8 p.m., on both Monday, December 3 and Monday, December 10, as work is performed on the electric distribution system in the area:

- **Chapman Highway between Tipton Station Road and E. Circle Drive** - southbound, curbside lane closed. One southbound lane and both northbound lanes will remain open during this time.
- **W. Hendron Chapel Road between Tipton Station Road and Chapman Highway** – full road closure. Alternate routes include Tipton Station Road, Henry Haynes Road, Babs Road, and W. Marine Road.

Follow-up advisories will be issued as necessary.

(Sequoyah Hills) Sequoyah Hills Area Road Closures [December 3-7] – KUB contract crews will implement the below road closures as needed daily, Monday-Friday, from 7 a.m. – 5 p.m., December 3 – 7, as work continues on the wastewater collection system in the area:

- Hiawatha Drive between Noelton Drive and Towanda Trail
- Noelton Drive between Chippewa and Alta Vista Way
- Chippewa Circle between Noelton Drive
- Dogwood Lane between Arrowhead Trail and Noelton Drive
- Arrowhead Trail between Dogwood Lane and Blows Ferry Road
- Mellen Avenue between Lyons view Pike and Arrowhead Trail

Access to area homes will be maintained, and flaggers and signs will be on site to assist with traffic control. Unless otherwise indicated, roadways will be re-opened outside of work hours. Follow-up advisories will be issued as necessary.

Some listed closures may extend beyond the scheduled times depending on the conditions encountered during excavation and construction. Appropriate traffic control measures will be in place at each location to assist motorists traveling in these areas. Due to the ongoing presence of workers and equipment, motorists are advised to use caution and expect temporary delays in these areas. Tennessee's **Move Over Law** requires motorists approaching a utility vehicle with flashing lights to move over if safe to do so, creating an empty lane buffer. When changing lanes is not possible, motorists must reduce speed.
