Re: Traffic Advisory – Lane/Road Closure Utility Work [All closures are weather permitting]

(Downtown) Downtown Lane Closures [September 21] – KUB crews will implement lane closures in the below locations of roadway from 5 a.m. – 9 p.m., on Saturday, September 21, as work is performed on the electric distribution system in the area:

- One southbound lane of Locust Street between Main Street and W. Hill Avenue closed
- W. Hill Avenue between Locust Street and Walnut Street reduced to one alternating lane
 of traffic.

The adjacent sidewalks will also be closed during this time. Traffic flow around the work zone will be maintained via flaggers, and follow-up advisories will be issued as necessary.

(Sequoyah Hills) Scenic Drive Road Closure [September 23] – KUB crews will close a short section of Scenic Drive between Blows Ferry Road and Choctaw Road to through traffic from 8 a.m. – 4 p.m., on Monday, September 23, as work is performed on the wastewater collection system in the area. Alternate routes include Choctaw Road, Chickasaw Road, South Garden Road, and Navaho Road. Appropriate signage and flaggers will be on site to assist with traffic control. Follow-up advisories will be issued as necessary.

Sequoyah Hills Area Traffic Impacts (September 23 - 27) – KUB contract crews will implement the below indicated traffic control measures during work hours, 7 a.m.- 5 p.m., Monday-Friday, September 23 - 27, as work continues on the wastewater collection system project in the area:

- Intermittent lane closures during work hours:
 - Taliluna Avenue between Agawela Avenue and Southgate Road
- Intermittent road closures as needed during work hours:
 - o Agawela Avenue between Cherokee Boulevard and Taliluna Avenue
 - o Kenesaw Avenue between Cherokee Boulevard and Taliluna Avenue
 - o Bluff View Road between Southgate Road and Holloway Drive

Some listed closures may extend beyond the scheduled times depending on the conditions encountered during excavation and construction. Appropriate traffic control measures will be in place at each location to assist motorists traveling in these areas. Due to the ongoing presence of workers and equipment, motorists are advised to use caution and expect temporary delays in these areas. Tennessee's **Move Over Law** requires motorists approaching a utility vehicle with flashing lights to move over if safe to do so, creating an empty lane buffer. When changing lanes is not possible, motorists must reduce speed.
