Question: Is there a detail for the retaining walls?

Answer: There are no details drawn by the engineer for the retaining wall, but the heights of the wall are on the drawing I provided Top of Wall (TOW) and Bottom of Wall (BOW) - shown in 2' intervals.

Question: On the west wall, the plan shows the top wall elevation @ 73.67 and it also shows the bottom elevation @73.67 at the north corner. The south end elevation is similar in nature. It shows the center of that wall @74.00. Can you please verify these elevations.?

Answer: Yes, these elevations are correct - there may not be a wall at the property line - the engineer is just showing the elevation here.

Question: How wide does the wall need to be?

Answer: 16" will be adequate

Ouestion: Is it a concrete wall?

Answer: It can be concrete or blocks

Ouestion: Does it need a footer?

Answer: If not concrete, no footer is needed, just compacted

Question: Does the site and the driveway have a stone base? If so, what type of

stone?

Answer: Yes, 57 stone

Ouestion: Is the site staked now?

Answer: Yes

Question: Is the chain link fence that is shown a different site? **Answer**: **The chain link fence is a different site - it's only on the drawing for reference**
