Separate sealed bids for the Isabella Towers, Eastbridge, Beverly Road, and South Doyle Sewer Rehabilitation and Beck Place Waterline Replacement, Control Number: 1198, will be received by the Knoxville Utilities Board, an agency of the City of Knoxville, (the "OWNER") 4505 Middlebrook Pike, Knoxville, Tennessee 37921, until 2:30 p.m. local time, on June 6, 2018, and then at said time publicly opened and read aloud.

Description of work:

The work includes the replacement of approximately 777 linear feet (LF) of 8-inch sanitary sewer lines with ductile iron and PVC pipe by open cut, rehabilitation of 1,435 LF of 8-inch sanitary sewer by CIPP lining, the replacement of twenty-three (23) 4-foot diameter sanitary sewer manholes and one (1) 4-foot diameter drop manholes, rehabilitation of 2 sanitary sewer manhole by cementitious lining, rehabilitation of 7 sanitary sewer manhole by polymer lining, 8 service lateral replacements, and all related appurtenances. This project also includes the replacement of approximately 220 feet of 2" galvanized waterlines with new 2" HDPE waterline and abandonment of the existing 2" waterline, and all associated valves, service reconnections and appurtenances as noted on the drawings.

- 2. CONTRACTOR shall provide all labor materials, equipment and incidentals as required for traffic control; sewer flow control; and all appurtenant and incidental materials and equipment, complete and in place in accordance with the Contract Documents for said project. CONTRACTOR shall restore the Site to a condition equal or better than the Site condition that existed prior to the initiation of work activities. CONTRACTOR shall provide Traffic Control Plan (TCP) and devices as required by the specifications.
- 3. A mandatory pre-bid meeting will be held on May 17, 2018, at 2:00 PM, EST, in the Procurement Conference Room at the KUB Hoskins Operations Center, 4505 Middlebrook Pike. You must attend this meeting in order to be eligible to bid.
