Separate sealed bids for the **864 Volunteer Boulevard Shortline 2017, Control Number: 1079**, will be received by the Knoxville Utilities Board, an agency of the City of Knoxville, (the "OWNER") 4505 Middlebrook Pike, Knoxville, Tennessee 37921, until **2:00 p.m. local time, on Monday, December 4, 2017**, and then at said time publicly opened and read aloud.
2. **Description of work:** This project includes the pipe burst replacement and installation of approximately 1,150 LF of new 8" diameter gravity sewer along existing alignments on Volunteer Boulevard within the City of Knoxville. The work also includes 480 LF of 8-inch (by 6 mm) cured in place pipe sewer lining. The work includes tie-ins to the existing sewer system and abandonment of 99 LF of existing 8" diameter gravity sewer.
