 Separate sealed bids for the Buffat Mill Reservoir Valve Replacement, Control Number: 645, will be received by the Knoxville Utilities Board, an agency of the City of Knoxville, (the "OWNER") 4505 Middlebrook Pike, Knoxville, Tennessee 37921, until 2:00 p.m. local time, on November 30, 2017, and then at said time publicly opened and read aloud.

2. Description of work:

Valve Vault Improvements: The work includes, but is not limited to: Replacement of one (1) existing 24-inch motor-operated butterfly valve with a new motor-operated butterfly, cut in a new 24-inch hand wheel operated butterfly valve, installation of french drain for surface and groundwater removal, excavation (including rock and borrow material), all mechanical, all electrical, and all plumbing systems as shown on the drawings and further described in the specifications. Work also includes conformance with all confined space entry and occupancy requirements.

Site Electrical: The work includes, but is not limited to: Installation of all electrical and SCADA power, control, and instrumentation conduits and conductors at the reservoir site, installation of all electrical and SCADA power, control, and instrumentation conductors between the reservoir site and the pumping station, remove existing Milltronics tank level measurement device and install new submersible transducer for tank level measurement and instrumentation conduits and wiring, replace one (1) existing pull box with new precast concrete structure, excavation (including rock and borrow material), final grading, cleanup, seeding, strawing, and all other items as shown on the drawings and further described in the specifications.
